### 2009 High School Mock Trial Invitational

Sixteen teams from several high schools began showing up early this morning, anxious and excited to compete in the 6<sup>th</sup> Annual Lake County Mock Trial Invitational. The tournament is sponsored by the Lake County Law Related Education Initiative (LRE) in partnership with the Circuit Court of Lake County and the support of the Lake County Bar Association and the Juvenile Officers Association.

The persons responsible for the planning of the annual event include Victoria Rossetti, a Circuit Judge, currently assigned to the felony division; Christen Bishop, an Assistant State's Attorney for Lake County; and teacher Stacey Gorman of Mundelein High School. "Several of the same students here today will be competing at the state level later this month in Springfield and, if they do well, may go on to the national competition," said Rossetti. (The Lake County Mock Trial Invitational is governed by the same rules and procedures that apply to the Illinois State Bar Association mock trial competition.)

Participating high schools this year included Carmel; Chicago Christian; Evanston; Highland Park; Lake Forest; Libertyville; Maine East; Maine West; Morgan Park; Mundelein; St. Charles East; St. Charles North; South Elgin; Wheaton Academy; York; and Zion-Benton.

In honor of the 200<sup>th</sup> anniversary of President Abraham Lincoln's birth, a case tried by Lincoln himself was selected as this year's choice for the mock trial. The case, entitled "People v. William "Duff" Armstrong," was based on what has been called the "Almanac Trial." As attorney for defendant Armstrong, Lincoln used an almanac to discredit the state's witness, and so it has been called the "Almanac Trial." The trial involved a criminal case wherein the defendant was charged with the murder of James Preston Metzker with a slingshot. The victim died three days later.

At the end of each round, students were evaluated on their presentation, effectiveness and ability by volunteer assistant state's attorneys and public defenders and private practitioners of Lake County. The evaluators graded the students using the same ISBA form that is used for scoring and critiquing in the state competition and also gave their comments and suggestions regarding the students' performances.
