

DRIVING DIRECTIONS

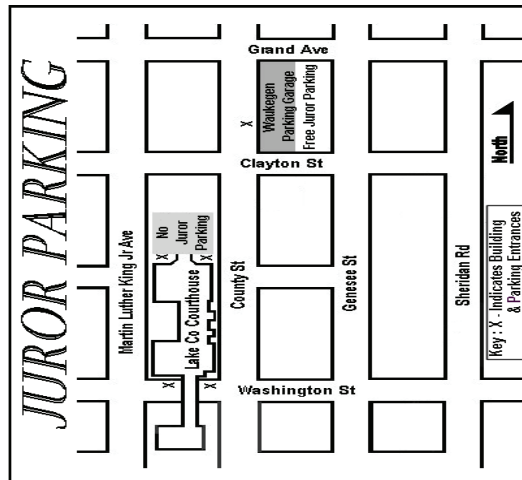
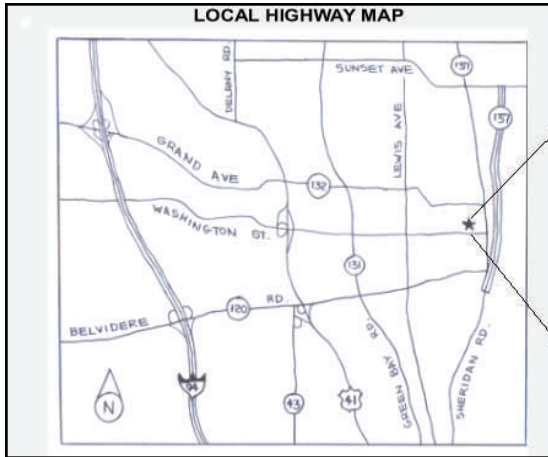
County St. is approximately 6 miles east of I-94.

The **County Building** is located at 18 N. County St. between Washington St. and Clayton.

The **juror parking garage** is located one block north at 225 N. County St. between Clayton and Grand Ave

Most travel east into Waukegan on Washington St. or Grand Avenue to County St. (Refer to the following maps or the maps on the back of your summons form)

JUROR PARKING

Free juror parking is provided in the City of Waukegan parking garage located at 225 N. County Street. It is a multi-level, red brick parking structure with green awnings. When you enter the garage you will pull a ticket to open the gate. It is important that you bring this ticket with you to the jury assembly room for validation. From the parking garage, cross County Street and walk one block south to the County Building's north entrance. ***Please be advised that parking anywhere other than the City of Waukegan Parking garage will be at your own risk and expense.***

MOTORCYCLE PARKING: Motorcycle parking is NOT permitted in the City of Waukegan garage. If you will be driving a motorcycle please call our office for alternate parking instructions.

DISABILITIES PARKING: Those entitled to disability parking are advised to park as close as possible to the County Building's SOUTH entrance on Washington Street. Several designated parking spaces are available in this area for persons with disabilities. Please contact our office if you need additional information or accommodations.

EMPLOYEE & EMPLOYER RESPONSIBILITIES

EMPLOYEES are required to give reasonable notice of jury service to their employer. Reasonable notice is defined as within 10 days of the date of issuance of the summons to the employee. Refer to your Employee Manual, Supervisor or Human Resource Department for details regarding your employer's jury duty policy.

EMPLOYERS in Illinois:

- May not deny employees time off for jury duty.
- May not require a night shift employee to work while such employee is doing jury duty during the day.
- May not discharge, threaten to discharge, intimidate or coerce any employee by reason of the employee's jury service.
- Are not obligated to compensate employees for time taken off for jury duty.

SMOKE FREE ILLINOIS ACT

Effective January 1, 2008, the Smoke-free Illinois Act 95-0017 prohibits smoking in virtually all public places and workplaces, including offices, theaters, museums, libraries, educational institutions, schools, commercial establishments, enclosed shopping centers, retail stores, restaurants, bars, private clubs and gaming facilities.

Smoking is not permitted within 15 feet of building entrances. Jurors are not permitted to leave the jury assembly room until the lunch break or until dismissed for the day.

JURY SUMMONS

Jury service is a vital function of democracy and one of the few responsibilities required of all qualified United States citizens. Prospective jurors are randomly selected from an annually updated database of Lake County residents who have been issued an Illinois Driver's License, Illinois State Identification Card, Illinois Disabled Person Identification Card or have registered to vote in Lake County. Approved criteria and documentation requirements for disqualification and excusal are explained in the attached juror questionnaire which must be completed and returned within 10 days of receipt.

While we realize most citizens take the responsibility of jury service seriously, we must make all summoned jurors aware that you may be guilty of a crime if you:

- (1) Fail to complete and return the juror summons and questionnaire.
- (2) Misrepresent information on the juror summons and questionnaire.
- (3) Fail to report for jury service as directed.

IMPORTANT INSTRUCTIONS

- All summoned jurors are required to complete and return the bottom portion of the enclosed summons form **within 10 days**. A return envelope is provided for your convenience.
- All requests for disqualification or excuse must meet specific criteria and include required documentation as indicated on the questionnaire. Requests will be denied if they do not meet the specified criteria and/or do not include required documentation.
- If you are requesting to be excused, disqualified or deferred you will receive a notice by mail confirming approval or denial of your request unless you have provided documentation of residency outside of Lake County.
- You will be expected to report as summoned unless you receive notification by mail of disqualification, excuse or deferral.
- **THIS BROCHURE CONTAINS IMPORTANT INFORMATION YOU MAY NEED TO REFER TO DURING YOUR JURY SERVICE. PLEASE RETAIN THIS BROCHURE UNTIL YOU HAVE COMPLETED YOUR JURY SERVICE.**

TERM OF SERVICE

The term of service for jurors in Lake County is **ONE WEEK**, unless you are selected for a trial that runs longer. You will not necessarily be required to report every day or all week; however, *you must be able to be available* for the week if selected to serve on a trial. It is very important that you do not schedule other important appointments during your week of jury service.

ALL JURORS WILL BE REQUIRED TO REPORT AT LEAST ONCE DURING THE FIRST TWO DAYS OF THEIR WEEK OF SERVICE

If you are not required to report the first day, you will be required to report the second day. Those not selected to serve on a trial their first day of service will be required to continue to monitor the information line and may be required to report for service on multiple days. Although you may be released earlier, you should plan to be at the courthouse until 5:00 p.m.

JUROR INFORMATION LINE 847-249-5879 (JURY)

- The juror information line is a 24 hour recorded message updated twice daily at 11:15 a.m. and 4:30 p.m.
- All jurors are required to make their first call to the juror information line anytime after 4:30 p.m. the Friday prior to their week of service.
- Each call to the information line will indicate the jurors (by call number) required to report at the next report time, or, when you are required to make your next call to the juror information line.
- All jurors summoned for the week will be called in at least once during the first two days of their week of service. Additional information and instructions will be provided at that time.
- Your final call to the information line at the end of the week will clearly indicate when your service is completed.

DISQUALIFICATION, EXCUSE OR DEFERRAL

QUALIFICATIONS FOR JURY SERVICE:

- United States Citizen
- Lake County Resident
- 18 years of age or older

EXCUSALS: Requests for excuse from jury service are reviewed based on very specific and consistent criteria as indicated on the reverse side of your summons form. Requests that do not meet the criteria or do not contain the required documentation will be denied.

DEFERRALS: We realize that schedule conflicts exist and therefore try to be accommodating in offering jurors a one time deferral of up to 6 months. Second requests for deferrals are granted only when circumstances are extenuating.

WHEN TO REPORT ?

Please review and follow the "**Juror Information Line**" instructions carefully. Reporting times may vary from day to day but are generally 8:00 a.m., 9:00 a.m. or 1:30 p.m. The information line message will include the exact report time each day. The release time each day varies based on trial schedules; however, you should plan to be at the courthouse until 5:00 p.m. Any juror who does not report for service or return for service as required will be considered to have "failed-to-appear" and will be assigned to a new week of service.

WHERE TO REPORT ?

All jury trials in Lake County take place at the main courthouse in the **Lake County Building** at 18 N. County Street, Waukegan. The **Jury Assembly Room 110** is located on the main floor of the building. From the juror parking garage enter the County Building at the first (north) entrance and walk across the lobby to the main floor hallway. Proceed straight down the hallway, following signage to the Jury Assembly Room.

WHAT TO BRING ?

Jurors are encouraged to bring items to keep themselves occupied during unavoidable idle time. Suggestions of items to consider bringing include laptop computers, paperwork, personal CD, DVD or MP3 players, books and magazines. Cell phones are allowed but we ask that you please use discretion in cell phone use in the assembly room. Free wireless internet access, magazines, public telephones, vending machines, a microwave oven, games, crossword and jigsaw puzzles are available to jurors in the jury assembly area. Please note that **ONLY** jurors are allowed in the jury assembly room.

RESTRICTED ITEMS

You will be required to pass through security upon entering the building. If you have any restricted items in your possession you will be required to permanently surrender the item to security or return it to your vehicle. Restricted items include sharp objects, metal utensils, sprays, glass bottles, cameras, and tape recorders. Your cooperation contributes to a safe facility for everyone.

LUNCH BREAK

The lunch break for jurors is generally between 12:00 noon and 1:30 p.m. The County Street Café and Starbucks are located in the building and there are several restaurants within walking distance. Jurors are free to leave the building and parking garage during the lunch break.

ATTIRE

Please keep in mind that the courts are conducted in a professional environment. Comfortable business or business casual attire is suggested. No uniforms. Wearing layers (sweaters/jackets) may be helpful due to indoor temperature variables and personal preferences.
