It accomplishes this mission by providing a fair and efficient system of justice, committed to excellence, fostering public trust, understanding and confidence.


SUPPORTING STATEMENT




YOUTH ASSESSMENT AND SCREENING INSTRUMENT

The YASI Profile “Wheel”




NEW LEGAL INVOLVEMENT BY COMBINED RISK & PROTECTIVE FACTORS


REFERRALS FOR TREATMENT SERVICES

Based on YASI Domains – Lake County 2010




TREATMENT COMPLETION RATES 2009-10

RE-ARREST RATES 2009-10





ANNUAL RE-ARREST RATE & COMMITMENT RATE TO DOC/DOJJ 2004-10 (Actual), 2011 (Projected)




SUBSTANCE ABUSE TREATMENT MODALITIES




Evidence-Based Approaches



- We decided to **open up and talk honestly** about ourselves and about alcohol and other drugs.
- We looked at what we liked about alcohol and other drugs, and **why we were using** them.
- We looked at our use of alcohol or other drugs to see if it has **caused harm** or **could cause harm**.
- We looked at **our responsibility** and the responsibility of others for our problems.
- We thought about where we seemed to be headed, **where we wanted to go**, and **what we wanted to accomplish**.
- We made **thoughtful decisions** about our lives and about our use of alcohol and other drugs.
- We **followed through** on our decisions about our lives and drug use. If we saw problems, we went back to earlier challenges and mastered them.






SEX OFFENDER TREATMENT MODALITIES





Advantages


- Designed for chronic juvenile offenders

- Extensive training
- Buy-in from community & social service agencies
- Addresses underlying causes, rather than behavioral problems


UDIS RE-ARREST RATES 2009-2010

Services for high-risk, low-protective factor youth






STRESS CHALLENGE COURSE – JR'S CHALLENGE

Mean Score Change over Time




High-Ropes Completers

COLLEGE OF LAKE COUNTY – JUDICIAL SERVICES

Behavioral Choices Module (BCM) – June 2011

- **What is BCM?**
 - 4 hour classroom curriculum for youth (age 13-17)
 - Focus on thinking errors
 - Target first-time offenders with charges of property offenses, disorderly conduct, and status offenses
 - Utilizes evidence-based practices, including cognitive restructuring , and restorative justice principles.
 - Referrals are made by Branch Court judge
- **Ineligible Referrals**
 - Minor drug- & alcohol-related offenses
 - Repeat offenders to Branch Court
 - Youth who previously completed BCM
