NINETEENTH JUDICIAL CIRCUIT
 LAKE COUNTY

IT IS HEREBY ORDERED Administrative Order 19-13 is hereby vacated.

IT IS FURTHER ORDERED that the Committees of the Nineteenth Judicial Circuit, Lake County and Special Circuit Assignments, are established by this Administrative Order. The Chief Judge shall be an ex-officio member of each committee and shall receive notice (and minutes if prepared) of all meetings. The Chairperson of each Committee may, (1) request that the Chief Judge add judicial or non-judicial members to a committee on a permanent basis; (2) request that the Chief Judge add judicial or non-judicial members to a committee on a temporary basis to deal with particular questions or problems, and (3) appoint subcommittees.
